PROMOTION TERMS AND CONDITIONS

A. Eligibility

1. This offer is available from 15/1/2026 to 14/2/2026.
2. This offer is exclusively available to all retail clients.

4. This offer is only available to the VT Markets' retail clients in the following countries/regions except Malaysia, Vietnam, India.

B. Campaign Mechanics

6. To participate in this offer, you must:
 - a. Opt-in to this offer via client portal after account registration.
 - b. Fulfill the trading requirement to claim the rewards from this offer.
7. The cashback is calculated based on the cumulative total notional volume by the client during the Promotion Period, subject to the following tiers and the total cap:
 - **A. Tier 1 (Standard Cashback Rate):**
 - Clients will receive a cashback of USD 2.50 for every cumulative USD 25,000 in trading volume.
